




After being duly sworn and under oath, James Roeder, states as follows:

1. Log entries of Sierra's firewall reflect that on June 29, 2005, connections to Sierra's server were made from the IP of "dritz.mako.ath.cx."
2. The above-referenced IP address, "dritz.mako.ath.cx" is the rr.com IP address assigned to David Ritz, 69.76.79.48. We determined that the rr.com IP address was assigned to David Ritz by doing an nslookup.
3. The July 2005 attempts to access Sierra's servers were undertaken via proxies, making identification of the perpetrator more difficult. However, the June 29, 2005 access, which was the first one following commencement of this litigation, was done without the use of proxies and shows that at least some of the access attempts were done by Mr. Ritz directly, without using a proxy to hide his conduct.
